Minutes:

Treasurer's Report:

- Annual Meeting cost \$651.16, Silent Auction raised \$930.
- CD maturing today for \$5273.82, next one matures in 3 months.
- *Motion*: to renew the CD for 6 months with the addition of \$5000, to be 1 or 2 CDs at the treasurer's discretion. By Becky 2nd Tina, approved.
- *Motion*: to put \$3200 in the TLPA, GRNA, and TLA joint education effort by a check to GRNA, after the TLA's share of the Golf Tournament funds have been received. By: Norton, 2nd Patricia, approved.
- *Motion*: to accept the treasure's report. By Chuck, 2nd Tina, approved.

Executive Director's Report:

- Shoreline survey fieldwork finished on Lakes Bellaire and Clam has been complete. The Clam lake survey was a cooperative effort with Friends of Clam Lake and uses a new technique employing an aerial survey.
- Interns will write Bellaire report with the Clam report to be finished later.
- Interns and Trish were taken for an aerial survey of their work area, etc.
- Alba well appeal by Star Township was denied by Michigan Judge Dennis Mack, but their Appeal the still in process at the federal level. Jack noted that a lawsuit has been filed in Circuit Court by Star Township, Antrim Co., and the Friends of the Jordan River.
- EPA has approved its joining the CKD stakeholder's group.
- Two E.coli samples have been taken in the TLA monitored streams.
- Noise gun engineering data is lacking,
- Annual meeting was a great success.
- TLA will encourage Christy Roman, Executive Director for Antrim County Conservation District, to write a letter to the new owners of Shanty Creek, outlining a proposed solution to the Maury Creek drainage problem. TLA would in turn support the letter.

Membership:
