51<sup>st</sup> Annual Meeting – August 24, 2017

The 51<sup>st</sup> annual membership meeting of the Three Lakes Association was held on August 24, 2017, from 5 to 9 pm, at the Norris-Fields farm, 5860 Aarwood Rd NW, Rapid City, Michigan.

Following the business meeting, Dr. Linda Greer, gave an entertaining and informative presentation on "Mercury in Our Fish: A Global Threat with a New Global Solution in Hand." Dr. Greer is currently serving as the Director of the University of Michigan Biological Station, while the regular director is on sabbatical leave, but, her "real" job is with the Natural Resources Defense Council, and her office is in Washington, D.C.
