## Minutes from the Annual Meeting of 2020

#### **Three Lakes Association**

54<sup>th</sup> Annual Meeting – August 6, 2020

The 54th annual membership meeting of the Three Lakes Association was held on August 6, 2020, via Zoom in webinar format, with business meeting at 5:00 p.m., results of the pre-meeting poll at 5:20 p.m., and a presentation at 5:30 p.m. by Dr. Jan Stevenson on what we now know about Golden Brown Algae, with a Q&A session in the final ten minutes..

#### Call to Order:

Executive Director Jeanie Williams presided over the meeting in the place of President Mike Bertram, who has graciously dedicated himself to running the Antrim County Ambulance Service for several months during this pandemic. She explained the tools available to all attendees, such as the Q&A box, the chat box, the hand-raising feature, and in-meeting voting. KC Babb is monitoring the Q&A panel and will bring questions to the TLA Panel for answers. Executive Director Williams reviewed the accomplishments of the past year.

#### Approval of Preceding Year's Annual Meeting Minutes:

**MOTION** Moved by Leslie Meyers, and seconded by Fred Sittel, to waive the reading of the minutes of the 2019 annual meeting of the Three Lakes Association (which were included in the meeting packet). Motion carried.

**MOTION** Moved by Leslie Meyers, and seconded by Greg Federickson, to approve the minutes of the 2019 annual meeting of the Three Lakes Association. Motion carried.

#### Treasurer's Report:

The treasurer's report was also included in the meeting packet. Treasurer, Ed Gourley, commented that the Association is financially very healthy and offered to respond to any questions. There were none.

**MOTION** Moved by Leslie Meyers, and seconded by Richard Knopf, to approve the treasurer's report for 2019 as presented. Motion carried.

#### Election of Officers and Board of directors:

The proposed slate of candidates was included in the meeting packet. Secretary Fields explained that terms run for two years, and half the Board is elected each year. The officers elected in odd-numbered years are the Vice President and the Treasurer. The officers elected in even-numbered years are the President and the Secretary: Mike Bertram, the current President and Tina Fields, the current Secretary, have both agreed to serve again.

Three of the six Directors at Large are up for re-election: Norton Bretz, Leslie Meyers, and Becky Norris.

There are eight zones, by township: Clearwater, Milton, Torch Lake, Central Lake, Forest Home, Helena, Custer, and Kearney. Nominations were opened from the floor. Richard Knopf self-nominated to serve for Helena Township.

There being no further nominations offered, nominations were closed.

Following the presentation, Dr. Stevenson responded to many questions on the possible causes and characteristics of Golden Brown Algae.
